MINUTES OF WALTON ON TRENT PARISH COUNCIL MEETING HELD ON 10 JULY 2023 AT 7.00PM AT THE VILLAGE HALL

<u>PRESENT</u> Parish Councillors P Byron, R Mizuro, S Hilton, M Rafferty, H Hearn, N Forrest, Cllr S Swann (DCC), Cllr A Wheelton (SDDC), Cllr G Jones (SDDC), C Henning (DCC Executive Director) & Parish Clerk.

Cllr P Byron welcomed everyone to the July Parish Council meeting and the attendance of C Henning (DCC Executive Director)

23/53 Declaration of Members Interests

23/54 Chris Henning (DCC Executive Director for Highways, Traffic & Strategic Planning)

In response to the letter on Traffic Impact Concerns, dated 17 May 2023, Chris Henning addressed the Parish Council to explain that South Derbyshire had not been forgotten and that the report compiled by Cllr Cupit, and circulated to the Councilors', detailed the response from DCC to the concerns. He stated:

- He understood the frustration of residents,
- DCC were working with SCC to address the issue of the new bridge together with Countryside as it is a
 developer led process,
- That DCC Highways as a Statutory Consultee would not support further development at Drakelow, unless it was underpinned by a traffic survey, which he was going to propose to his team to better understand the impact. However, the final decision would be with SDDC Planning.
- He would discus with the legal team the legality of adopting the bridge from the Derbyshire side only,
- That DCC were committed to the events at Catton, adding to the rural economy, but a review of the mitigation plan due to the number of vehicles was necessary.

Cllr P Byron thanked Chris Henning for attending and that hopefully he clearly understood the frustration felt by residents in the area and hoped that assistance would be forthcoming

a) Review of Outstanding Resolutions/Actions - Appendix A

i. **Village Hall Lighting –** The Clerk reported that the lighting in the main hall was already diffused and as such very little can be done to remove the glare.

- i. **Police Incident Figures –** The Council noted the incident figures provided by the Police.
- ii. **Catton Hall Events –** The Clerk reported that there had been a number of complaints with regards to the loudness of the music until 3.00am at the Sausage and Cider Festival and the concern for the forthcoming Bloodstock event, All complaints have been forwarded to SDDC.
- iii. Barr Hall Farm Energy Storage System The Clerk reported that there had been correspondence from Novus Renewable Services who are developing plans to construct and operate an energy storage system at Barr Hall Farm. The company intend to engage with the local community in the coming months but would like to introduce the project to the Parish Council.

Resolved: Walton on Trent Parish Council agreed to invite Novus Renewable Services to the next meeting on 11 September 2023.

iv. **Remedi – Restorative Services -** The Clerk stated that a restorative organization called Remedi who are working in Derbyshire to organize reparative activities for young people and adults would like to attend a Parish Council meeting to discuss the project and gain feedback as to what activities they could facilitate.

Copy of email sent on 13 July 2023

Dear Mr Henning,

On behalf of the Walton on Trent Parish Council I would like to thank you for attending the Parish Council meeting on Monday 10 July 2023.

One of the main points of the conversation was in respect to the prospect of Countryside (Drakelow Developers) asking for an increase in the number of houses that they can have occupied before the bridge has to be built. The key extract on this matter from the response to our letter on traffic concerns around Walton on Trent from Charlotte Culpit, Cabinet Member for Highways, Assets and Transport at DCC is as follows:

"I note your point that the Parish Council will object to any planning application or amendment application by the developer seeking to increase the number of houses allowed to be occupied at Drakelow before the bridge is occupied and I can confirm that Derbyshire County Council acknowledge your views and concerns, as outlined by our efforts above, and would want the design and delivery of the bridge to be agreed and contractually committed in totality before any consideration of raising the cap on the number of completed and sold dwellings on site. This would seem to me essential for the new residents and, most importantly, for existing communities such as yours to have restored confidence that the bridge will be progressed by the developer as well as to alleviate the traffic and environmental concerns you detail."

As Countryside are in the process of imminently requesting a variation to the existing Section 106 for the implementation of the bridge, that is to move from 400 houses occupied (already upped from the original 100) to something substantially higher - we expect 800-1200. The Councillors sincerely hope that, as discussed and you committed to look into, do your utmost to support this community by:

1) As DCC Highways are a statutory consultee, object to such an application on the basis that the surrounding road network cannot sustain the additional traffic that will come with the increased number of houses.

How will DCC and SCC highways who are both statutory consultees in the planning process be able to support their response with evidence?

- 2) Ensuring that the formal DCC Highways response to any request for additional houses at Drakelow from the developer shall be within the requisite time required given that the application is likely to be made during the summer holiday period.
- 3) Ensuring that DCC Highways will look to conduct traffic surveys in and around Walton on Trent, particularly at the Bailey Bridge, on Drakelow Road and at the Stapenhill bridge for both day to day traffic and around and during events that are on at Catton Hall (to identify traffic flow both in and out of South Derbyshire). The Parish Council believe this is needed as supporting evidence for any current and future planning applications, including the NSIP Oaklands, Drakelow and the development of the bridge. A survey id essential to give a clearer understanding of the impact traffic is having in the area.
- 4) Endeavouring to work with SCC and the developers at Drakelow to agree an acceptable and compliant design for the new bridge in the shortest possible timescales. We would also like to point out that the current causeway to the Bailey Bridge is not being removed and will remain the

prime barrier to flood water travelling downstream. We would expect that DCC and SCC will do everything within their powers to support this bridge to its construction and adoption.

- 5) Exploring the legitimacy or legality of agreeing to adopt the Derbyshire side of the new bridge crossing independent of Staffordshire's stance.
- 6) Evidencing that DCC (and presumably SCC) Highways can no longer mitigate the events at Catton Hall which are now causing public nuisance. At the last festival, signage was ignored and with a large equestrian event, also run at the same time at the Hall caused cars to back up down the A38. There was no traffic monitoring, Police or Highways staff on site or monitoring the agreed traffic management plan which was clearly not followed by lorries or cars. If DCC are unable to mitigate due to SCC road and bridge closures/restrictions a report is needed to SDDC licensing stating so. It was made clear to you these events are causing misery and economic loss to residents and businesses in this area with zero benefit to the South Derbyshire economy bar the landowner.

Once again thank you for attending, where hopefully you clearly understood the frustration of residents and we look forward to your help in getting Walton on Trent village out of the currently bad and deteriorating traffic environment it finds itself in.
